- + On day of a Wedding event if services are prolonged by 30 minutes a \$100/hr fee will be applied.
Example: if services are scheduled between 2-4pm fee will begin at 4:30.
- + Dog walks must be cancelled 24 hour before scheduled walk or are subject to a cancellation fee (half of walk dollar amount)
- + We understand that our sitters main priority is the safety and well-being pets(s)

Terms & Conditions

- # In group settings your dog should be non-aggressive and well socialized with other dogs and people. Should your dog become aggressive, Pups and Crumpets/Pups and Nuptials will not be liable for any damages or financial repercussions.
- # I confirm all behavioral and medical issues have been disclosed and the dog does not have a communicable illness. This would include things such as disclosing if a dog has ever bitten a person or animal, resource guarding issues, reactivity issues, escape/runaway tendencies (over/under fences, through doors), shown aggression with other dogs and if they are spayed or neutered.
- # If agreed upon, I consent my dog to be walked with other dogs **YES or NO _____**
- # I acknowledge that there is an inherent risk of illness or injury when dogs are outdoors or in a group situation, and nicks, scratches or other ailments aren't unusual.
- # I acknowledge that pets are instinctual in nature and are not always controllable even with the highest level of care is provided.
- # Your dog must remain current with required provincial vaccinations.
- # Your dog must be free of internal/external parasites and be on an annual flea & tick prevention from May to November.
- # Owners are to provide properly fitted collars, harnesses, leashes, and coats/boots, if necessary. Owners must also assure that all equipment is in good working order, Pups and Crumpets/Pups and Nuptials will not be liable for faulty equipment.
- # Pups and Crumpets/Pups and Nuptials are not responsible for replacing harnesses, leashes, coats, boots, license/name tags, keys, etc. that may get damaged during walks.
- # Pups and Crumpets/Pups and Nuptials employees are not trained in veterinary medicine and therefore will not be responsible for detecting or diagnosing illness or injury.
- # Owners are responsible for keeping their dogs' nails clipped on a regular basis in order to minimize scratches and minor injuries when dogs interact and play.
- # Pups and Crumpets/ Pups and Nuptials reserve the right to deny service or terminate service because of safety concerns, failure to comply with policy, or inappropriate, uncomfortable circumstances.
- # Pups and Crumpets/ Pups and Nuptials are not responsible for injuries involving pre-existing or age-related conditions.
- # Pups and Crumpets/ Pups and Nuptials are not responsible for damage to your clients' home caused by pets.
- # The pet owner assumes responsibility for any harm or damaged caused by their dog.

Emergency Procedures:

Pups and Crumpets/Pups and Nuptials carry a mobile phone for emergencies. If your dog is lost, injured, or sick, the protocol is as follows:

If lost:

- ✚ Contact emergency phone number on client information sheet as soon as possible.
- ✚ Contact Animal Services
- ✚ Attempt to locate the missing dog with the assistance of our dog walking community

If injured or sick:

- ✚ If Pups and Crumpets/Pups and Nuptials deems immediate veterinary care to be necessary, the walker will transport the dog to his or her veterinary clinic/hospital (if they are available and can accommodate the nature of the dog's injury or sickness), or to the nearest Veterinary Emergency Clinic (VEC). The walker will also attempt to reach the client/owner while the animal is in transit (if possible).
- ✚ If the client/owner is unreachable Pups and Crumpets/Pups and Nuptials will have the attending veterinarian proceed with any treatment(s) required excluding euthanasia.
- ✚ The client/owner of the dog will assume all financial responsibility for the veterinary test(s), treatment(s), /hospitalization fee(s) etc...
- ✚ Please have your credit card on file with your veterinarian to assure that your dog can be cared for immediately. Please fill out vet release form.

House emergency:

- ✚ I acknowledge that Pups and Nuptials/ Pups and Crumpets are not liable for fire, gas leaks, break-ins, storm damage, etc. In the unlikely event of such, Pups and Nuptials/Crumpets, will have owner's pet's health and safety at the most forefront. We will contact owner and necessary authorities immediately.
